*This form has been designed to aid you in registering your county's delegation to the 2010 Leadership Development Conference. Please follow the instructions below.*

1. Registration for the 2010 Leadership Development Conference will be on-line. On-line registration will be available Tuesday, January 5, 2010.
2. Participants will register as:
  - Agent: the Extension agent attending with the group.
  - Member: a 4-H member attending who is not a Senator.
  - Leader: a 4-H leader attending the **entire** conference.
  - Senator: a 4-H member attending who is a Senator.
  - District President: a 4-H member attending who is on the State 4-H Officer Team.
  - State President: for the State President ONLY.
  - State Vice President: for the State Vice President ONLY.
  - Leader Officer: a 4-H leader attending who is an officer in the Leader's Council.
  - Award Recipient: a 4-H member or leader attending the banquet as an award recipient.
  - Guest: a family member, friend or legislative representative attending the banquet **only**.
3. 4-H Day at the Capitol will be on Monday, January 25, 2010. If the participant is an award recipient attending the entire conference registration is \$100. The registration fee for guests attending only the banquet is \$50. A late fee of \$20 per person will begin at 11:59 p.m. on Tuesday, January 12, 2010, and final registration will close at 11:59 p.m. on Friday, January 15, 2010.
